## Presentation

Presentation of research findings from the research project: **“A waste of time or no time to waste?”**

**Assessing the impact of international reparative justice procedures**. The findings are based on:

- legal systematic content analysis of four international courts’ practice on reparations (i.e. Extraordinary Chambers in the Courts of Cambodia (ECCC), European Court of Human Rights (ECtHR), Inter-American Court of Human Rights (IACtHR), and International Criminal Court (ICC)); and
- qualitative research with beneficiaries of reparations (i.e. in ECCC cases - 001 and 002, ECtHR case -Cyprus v Turkey (just satisfaction), IACtHR case - Rio Negro Massacres v Guatemala at the IACtHR, and ICC case - Katanga), and with non-beneficiaries.
